**Tournament Program**

**Dates:** Saturday, May 18<sup>th</sup> & Sunday May 19<sup>th</sup>; Friday May 17<sup>th</sup> Sight-in/Practice Day

**Times:** Saturday, 8:00am, presentation of the colors & safety briefing; 1<sup>st</sup> relay firing will begin promptly at 8:30; 2<sup>nd</sup> relay following conclusion of 1<sup>st</sup> relay. Sunday, 7:30 presentation of colors & safety briefing, 1<sup>st</sup> Relay firing will begin promptly at 8:00am. EIC Matches consisting of Service Pistol, Service Revolver & .22 RF will be fired on Saturday at the conclusion of the Centerfire Match

**Location:** Brassmasters Range at White Horse Firearms and Outdoor Education Center, 127 White Horse Lane, Philippi, WV 26416. Large Rustic WV DNR Sign at the entrance of Crouse Road, County Road 20/3, off WV State Route 20

**Eligibility:** Open to all eligible competitors, you do not have to be a member of a Civilian Marksmanship Program Affiliated Club (CMP) to participate

**Entry Fees:** This is a CMP Sanctioned Tournament. A package entry fee of \$70 includes firing all three (3) stages: .22, Centerfire and .45 in the Precision Pistol/Bullseye 2700 over both days of the competition. Should a competitor wish to compete in only one (1) or two (2) stages in the 2700, the entry fee will be \$25 per stage. CMP Sanctioned EIC Service Pistol, Service Revolver & .22 Rimfire Leg Matches, the entry fee is \$20-- \$15 of each entry fee is required by the CMP

**Classification:** Current CMP Outdoor Precision Pistol Classification. Competitors without a current CMP Classification may compete on their current NRA Outdoor Precision Pistol Classification or a current NRA Temporary Classification Score Record Book. Unclassified competitors will compete in the Master Class. Current CMP/NRA classification checks will be made prior to the tournament and random checks may be made during the tournament

**Awards:**

- Open Winner, Award & \$100 cash
- Special Class Awards: High Junior, High Woman, High Senior & High Grand Senior
- Aggregate Winner of High Master, Master, Expert, Sharpshooter & Marksman
- Second highest scoring High Master, Master, Expert, Sharpshooter & Marksman
- .22 Only (full 2700) Open Winner, High Junior & High Woman
- 2700- 22 High Score
- .22 Aggregate Winner
- Center Fire Aggregate Winner
- .45 Aggregate Winner

Open Winner-1 award, all competitors are eligible for one (1) award, except for Aggregate Stage Winners  
2700 stages are: .22 caliber: Matches 1, 2, 3, 4 & 5=900 aggregate; CF Matches: 6, 7, 8, 9 & 10=900 aggregate; .45  
Matches: 11, 12, 13, 14 & 15 =900 aggregate. Leg Points and Medals provided by the CMP. The award schedule for  
the 2700 is based on a minimum of 6 (six) entries per class. If less than (6) six entries in a class, that class may be  
combined with the next higher class at the discretion of the Tournament Sponsor, except the Master Class

**Rules & Course of Fire:** Current CMP Precision Pistol rules governing a sanctioned tournament will apply to the  
2700 and the EIC Matches. Challenge fee will be \$1.00. The Tournament Scoring Officer will make all challenge  
decisions, (Rule3.10.5) which will be final. Challenge Fee will be returned if challenge is upheld. Challenges to  
posted scores of completed relays must be made directly to the Statistical Officer or the Scoring Officer before the  
presentation of awards. Targets will be: 50-yard slow fire B-6; 25 yard timed and rapid-fire B-8. Competitors will be  
squadred. Course of fire for each gun of the 2700, will be: 2 slow fire targets, the National Match Course, 2 timed  
fire targets and 2 rapid fire targets. Course of fire for the Service Pistol & .22 Rimfire EIC Matches will be the  
National Match Course. Course of Fire for the Service Revolver will be the 40 shot President's Pistol Match  
consisting of 2 slow fire targets,1 timed & 1 rapid fire target. Competitors may use a .22 caliber Rimfire Pistol  
throughout the 2700 course of fire and all stages; designate this option on Entry Form

**Registration:** Pre-registration will be accepted via U.S. Mail, with a check or money order (in U.S. funds) for all  
stages entered to range capacity. Pre-registration for all stages of the 2700 & relay preference will receive priority  
then; walk-up entries to range capacity will be accepted. Should entries exceed range capacity, you will be placed  
on a waiting list and if there are cancellations, you will be notified via telephone, email or text message and asked  
if you wish to participate or cancel. When submitting your entry form for the full 2700, please indicate preference  
for 1<sup>st</sup> or 2<sup>nd</sup> relay; we will do our best to accommodate your choice. If there is a discrepancy regarding date of  
entry receipt, entry postmark will determine availability of registration and relay preference

**General Information:** Safety Flags/Empty Chamber Indicators, eye and hearing protection are mandatory. The  
range is equipped with electronically-timed-pneumatic-turning targets and covered firing points. Information  
regarding lodging accommodation appears on Page 3. The range will be open Friday, May 17<sup>th</sup> from 12:00 until  
8:00pm for sight-in/practice, walk-up registration and camping setup. If EIC Matches exceed range capacity,  
preference will be shown to non-distinguished competitors. Random trigger checks may be made for the 2700 &  
EIC Matches

**Food & Refreshments:** Breakfast, both days will be on your own; however, refreshments will be available at the  
range both days. Lunch (sub sandwich) will be available at the range on Saturday, cost included in your entry fee,  
make your sub selection on your Entry Form

**Camping:** Primitive camping is available at the range, at no charge; however, no electrical, water or sewer hook-  
ups are available; portable toilet facilities will be available

**Security Services:** No security services will be provided by Brassmasters or the White Horse Center. It is therefore  
suggested that personal valuables be kept in a secure location

Conclusion of Competition & Awards Ceremony

- Targets will be scored on the range, competitors will act as scorers. Score cards are to be passed right & score competitor on your left
- Junior shooters are encouraged to participate, but must be accompanied by a parent or legal guardian or a parent/legal guardian approved sponsor with a *Brassmasters' Waiver and Release Form* signed by a parent or legal guardian
- Competitors wanting to complete the full 2700 on Saturday will be accommodated to the extent possible on a space-available basis. Final decision rests with the Match Director
- Competitors are expected to be at the Ready Line and prepared to occupy their assigned firing point on the firing line 15 minutes before their relay is called to the Firing Line. Should a competitor fail to occupy their assigned position on the Firing Line when their relay is called, their assigned position will be given to a competitor ready to fire

The Tournament Sponsor reserves the right to make changes to the Tournament Program including relay starting times, squad competitors, combine competitors to fill vacant positions on any stage or relay and other changes that it deems are in the best interest of the tournament, consistent with current CMP rules. Any changes prior to the day of competition will be posted on the Range Bulletin Board

This tournament will only be delayed or stopped for severe weather in the area or targets repeatedly blow out of target holders. If competition stops due to severe weather, winners and awards will be determined by scores of all matches of the 2700 completed before stoppage. There will be no refunds for uncompleted matches or to those failing to fire (DNF) in matches registered to enter
