# BRASSMASTERS, INC. IS PLEASED TO SPONSOR The 2025 Annual West Virginia Strawberry Festival Bullseye/Precision Pistol Championships

Sanctioned by the Civilian Marksmanship Program & Sponsored by the West Virginia Strawberry Festival Association <u>Tournament Program</u>

Dates: Saturday, May 17th & Sunday May 18th; Friday May 16th Sight-in/Practice Day

**Times:** Saturday, 8: 00a.m. presentation of the colors & safety briefing. The 1st relay firing will begin promptly at 9:00am 2<sup>nd</sup> relay following conclusion of 1<sup>st</sup> relay. EIC Matches consisting of .22 RF & Service Pistol will be fired on Saturday. Sunday, 7:30 presentation of colors & safety briefing, 1<sup>st</sup> Relay firing will begin promptly at 8:00am. The .45 Match & EIC Revolver Match will be held on Sunday, May 18<sup>th</sup>

<u>Location:</u> Brassmasters Range, White Horse Firearms and Outdoor Education Center, 127 White Horse Lane, Philippi, WV 26416. Large Rustic WV DNR Sign at the entrance of Crouse Road, County Road 20/3, off WV State Route 20 North

**Eligibility:** Open to all eligible competitors. You do not have to be a member of a Civilian Marksmanship Program Affiliated Club (CMP) to participate. All competitors and guests entering the range will be required to sign a *Brassmasters' Waiver & Release Form* 

Entry Fees: This is a CMP Sanctioned Tournament. A package entry fee of \$50 includes firing all three (3) stages: .22, Centerfire and .45 in the Precision Pistol/Bullseye 2700 over both days of the competition

Should a competitor compete in only one (1) or two (2) stages in the 2700, the entry fee will be \$20 per stage. CMP Sanctioned EIC Service Pistol, .22 Rimfire & Service Revolver Leg Matches, the entry fee is \$20-- \$15 of each entry fee is required by the CMP

<u>Classification:</u> Current CMP Outdoor Bullseye/Precision Pistol Classification. Competitors without a current CMP Classification may compete on their NRA Outdoor Precision Pistol Classification or a current NRA Temporary classification Score Record Book. Unclassified competitors will compete in the Master Class. Current CMP/NRA classification checks will be made prior to the tournament, and random checks may be made during the tournament

### Awards:

- Aggregate Winner of High Master, Master, Expert, Sharpshooter & Marksman
- Second highest scoring High Master, Master, Expert, Sharpshooter & Marksman
- Special Awards: Open Winner, High Woman, High Senior, High Grand Senior & Junior Winner & .22 Winner .22 Winner, must fire.22 caliber through all three (3) stages of the tournament

2700 stages are: .22 caliber: Matches 1, 2, 3, 4 & 5=900 aggregate; CF Matches: 6, 7, 8, 9 & 10=900 aggregate; .45 Matches: 11, 12, 13, 14 & 15 =900 aggregate. Leg Points and Medals provided by the CMP. The award schedule for the 2700 is based on a minimum of five (5) entries per class. If less than five (5) entries in a class, that class may be combined with the next higher class at the discretion of the Tournament Sponsor, except the Master Class Rules & Course of Fire: Current CMP Precision Pistol rules governing a sanctioned tournament will apply to the 2700 and the EIC Matches. The challenge fee will be \$1.00 & challenged target will be given to a 3-person jury, Challenge Fee will be returned if challenge is upheld. Challenges to the posted scores of completed relays must be made directly to the Statistical Office or the Chief Range Officer before the presentation of awards. Targets will be: 50-yard slow fire B-6; 25 yard timed and rapid-fire B-8. Competitors will be squaded. Course of fire for each gun of the 2700, will be: 2 slow fire targets, the National Match Course, 2 timed fire targets and 2 rapid fire targets. The course of fire for the EIC Service Pistol & .22 Rimfire will be the National Match Course. Course of Fire for the Service Revolver will be the 40 shot President's Pistol Match consisting of 2 slow fire targets, 1 timed fire & 1 rapid fire target. Competitors may use a .22 caliber Rimfire Pistol throughout the 2700 course of fire in all 3 stages; designate this option on Entry Form

Registration: Pre-registration will be accepted via U.S. Mail, with a check or money order (in U.S. funds) for all stages entered to range capacity. Pre-registration for all stages of the 2700 & relay preference will receive priority then; walk-up entries to range capacity will be accepted. Should entries exceed range capacity, you will be placed on a waiting list and if there are cancellations, you will be notified via telephone, email or text message and asked if you wish to participate or cancel. When submitting your entry form for the full 2700, please indicate preference for 1st or 2nd relay; we will do our best to accommodate your choice. If there is a discrepancy regarding date of entry receipt, entry postmark will determine availability of registration and relay preference

**General Information:** Safety Flags/Empty Chamber Indicators, eye and hearing protection are mandatory. The range is equipped with electronically-timed-pneumatic-turning targets and covered firing points. Information regarding lodging accommodation appears on Page 3. The range will be open Friday, May 16<sup>th</sup> from 12:00 until 6:00pm for sight-in, practice, walk-up registration and camping setup. The .22 and Center Fire Matches and the EIC .22 Rimfire & Service Pistol Leg Matches will be held on Saturday, September 17<sup>th</sup>. Sunday, September 18<sup>th</sup>, the 1<sup>st</sup> & 2<sup>nd</sup> relays will be devoted to the .45 Stage. Service Revolver Match will follow the .45 stage. Should entries for the EIC .22 Rimfire, Service Pistol and Service Revolver Matches exceed range capacity, preference will be shown to non-distinguished competitors. Random trigger checks may be made for the 2700 & EIC Matches

<u>Food & Refreshments:</u> Breakfast, both days will be on your own; however, refreshments will be available at the range both days. Lunch will be available at the range on Saturday & Sunday

<u>Camping:</u> Primitive camping is available at the range, at no charge; however, no electrical, water or sewer hookups are available; portable toilet facilities will be available; campers must be fully self-contained <u>Security Services:</u> No security services will be provided by Brassmasters or the White Horse Center. It is therefore

suggested that personal valuables be kept in a secure location

**Conclusion of Competition & Awards Ceremony** 

- A scoring overlay may be used, However, DO NOT insert a scoring plug, call for a range officer.
   If a scorer or competitor inserts a scoring plug, the challenge will be disallowed
- Junior shooters are encouraged to participate, but must be accompanied by a parent or legal guardian or a parent/legal guardian approved sponsor with a *Brassmasters' Waiver and Release Form* signed by a parent or legal guardian
- Competitors wanting to complete the full 2700 on Saturday will be accommodated to the extent possible on a space-available basis. Final decision rests with the Match Director
- Competitors are expected to be at the Ready Line and prepared to occupy their assigned firing
  point on the firing line 15 minutes before their relay is called to the Firing Line. Should a competitor
  fail to occupy their assigned position on the Firing Line when their relay is called, their assigned
  position will be given to a competitor assigned to another relay, but ready to fire
- All competitors will receive a Brassmasters Logo Gift. There will be a 50/50 drawing, proceeds to sponsor West Virginia State Pistol Teams at Camp Perry

If competition stops due to severe weather, winners and awards will be determined by scores of all matches of the 2700 completed before stoppage. There will be no refunds for uncompleted matches or for those failing to fire (DNF) in matches registered to enter
